ANNOUNCEMENT TO SHAREHOLDERS ABOUT SCHEDULE AND PROCEDURE OF IMPLEMENTATION OF STOCK SPLIT

Board of Directors of PT Multi Prima Sejahtera Tbk. (The "Company") hereby notifies the shareholders that the Company's Extraordinary General Meeting of Shareholders held on April 28, 2017 has approved, among other things, changes in the Company's articles of association concerning the change in the par value of the Company's shares and the implementation of Stock Value Splits "Stock Split") from the original value of Rp.500, - (five hundred rupiah) per share to Rp.100, - (one hundred rupiah) per share as contained in the Deed of Resolution No.85 dated April 28, 2017 made before Stephanie Wilamarta, SH, a notary public in Jakarta and has been recorded in the Legal Entity Administration System based on a letter from the Ministry of Justice and Human Rights of the Republic of Indonesia (Kemenkumham) with the Acceptance of the Report of Amendment of the Company's Articles of Association No.AHU-AH.01.03-0132970 dated 03 May 2017 And List of Company No.AHU-0057389.AH.01.11 year 2017 dated 03 May 2017.

The Company will perform Stock Split with a ratio of 1: 5 (one to five), every 1 share from the original Rp.500, - (five hundred rupiah) per share to 5 (five) new shares with new nominal of Rp 100, - (one hundred rupiah) per share.
