Dengan ini diberitahukan bahwa Direksi PT Surya Citra Media Tbk ("**Perseroan**"), dengan persetujuan Dewan Komisaris Perseroan, pada 4 November 2024, telah memutuskan dan menyetujui untuk membagikan Dividen Interim untuk tahun buku yang berakhir pada tanggal 31 Desember 2024 (selanjutnya disebut "**Dividen Interim**") sebesar Rp5,- (lima Rupiah) per lembar saham.
